

NOCK DEIGHTON AGRICULTURAL LLP SALES CONDITIONS OF ENTRY FOR POULTRY & EQUIPMENT

- 1. Entries closed on the date indicated below, however the sale may be full before the closing date, therefore an early response is recommended to ensure acceptance of entries.
- 2. ENTRY FEES MOST ACCOMPANY THE ENTRY FORM. Entry fees are non-refundable.
- Commission will be deducted from the sale price and the balance forwarded to the Vendor within two weeks of the sale. If
 payment has not been received within three weeks, please contact the Auctioneers, Nock Deighton Agricultural LLP,
 immediately on 01746 762666.
- 4. Vendors may stipulate a **Reserve Price** for any lot. <u>Please check on the morning of the sale that reserves have been placed on your lots and they are correct</u>. Reserves must be in whole pounds and per Bird. Should a lot fail to reach its reserve it will be passed and no commission will be charged.
- 5. All stock must be of good quality and true to type. Stock must be 100% healthy and in clean condition. Any entry which does not comply with these requirements, will be rejected and no refund of entry will be made. It is in your own interest to ensure that only good birds are entered.
- 6. A maximum of four birds per pen will apply and under no circumstances will more than four birds be allowed however, the following exceptions apply;
 - a. Hens with Chicks i.e. a broody mother or foster with babies such entries to be sold as a group and any reserve should be for the lot, not per bird.
 - b. Cage, Aviary Birds & Pigeon entries a maximum of 6 birds per lot will apply. Bidding for these lots will be per bird.
 - c. Young stock entries a maximum of 12 birds per lot/box. Bidding for these lots will be per bird.

NOTE. Young Stock and Quails & Hens with Chicks must be entered in suitable secure display boxes/cages which allow prospective purchasers to see the birds (mesh top) and that can be sold with the birds. Please ensure that boxes are large enough for the birds to stand and move around in and have good ventilation.

- 7. Young Stock. All birds must be OFF HEAT. Chick must be 4-11 weeks old. Waterfowl must be 2-6 weeks old. Chickens 12 weeks + and Water Fowl 7 weeks + will be allotted cages/pens. The Sale Organisers and Auctioneers will refuse to sell any stock that is too young or in need of heat and no refunds will be given. Anyone found to be selling all male birds will be refused entry in this section at future sales and payment for the lots will be withheld.
- 8. Alteration or Substitution of lots of the sale day may only be made at the discretion of the Sale Organiser. As prospective buyers may travel long distances on the strength of the catalogue entries, every effort should be made to ensure that all birds, as entered, are available on the sale day. Please ensure that any alteration of your original entry is clearly displayed on the cage so that it is clear to prospective buyers and the Auctioneer's staff in the market office are informed in writing before the commencement of the sale.
- 9. No advertising will be allowed on cages/pens at any time. Advertising space is available on the catalogue. Please contact the Auctioneers for further details.
- 10. All lots must be removed within one hour of the end of the sale. Any lots left after this time will be sold to the best offer available at that time, regardless of any reserve, which will be paid to the Owners, less the usual commission.
- 11. Vendors are responsible for the safety (cable ties to secure cages are available from the equipment stand) and well -being of their birds (including the provision of containers for water and feeding etc.) up until the fall of the hammer. Purchasers are immediately responsible thereafter.
- 12. All equipment offered for sale must be in good working order unless otherwise stated. Any faults must be declared in writing on the lot on the sale day; failure to do this will result in payment for the lot being withheld, commission being deducted and the lot being returned at your expense. Purchasers will have until 10am on the Monday following the sale to report any faults not declared. Items can be 'sold as seen' where there is no comeback; this must be stated on the entry form. Any lot not in saleable condition will be rejected and no refund of entry fee will be made.
